

Meeting Minutes November 21, 2011

## Opening:

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Council Members Present: Mark Eagleson, Terry Helmer, Richard Greene, Bruce Eagleson, Bill D. Eberhard, Laurie Miller

Council Member Richard Greene made a motion to open the meeting with flexibility, Member Mark Eagleson seconded the motion. Motion carried.

#### Water:

<u>WASTEWATER</u>: Monthly report. Generator plans are not quite ready. Member Eagleson asked if we should consider looking at the used ones that the County will be selling. It was also mentioned that the fire department has mobile generators that need to be located.

<u>FIRE</u>: Ladder truck failed the flow test. Rescue 10 will need services and a new light bar. Pumper 12 will be delivered sometime during the first part of December.

The Council discussed appointing a new fire chief. Chief Huffman said he would accept the position if the Council would reduce the commitment to 1 year. Member Greene made a motion to appoint Matt Huffman as fire chief for 1 year, Member M Eagleson seconded the motion. Motion carried.

<u>**POLICE**</u>: The new car is in, they are working on getting it ready for use. Got a thank you from Homeland Security for the help they received from Officer Tony Clark.

Street Dept: Working on leaves and putting up Christmas Decorations.
