Meeting Minutes - December 7, 2015

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

President Arroyo opened the meeting at precisely 7:00 pm.

Member Mickem made a motion to approve the agenda, Member Bowser seconded the motion. Motion carried.

Council Member Mickem made a motion to approve minutes from the November 16, 2015 meeting. Member Bowser seconded the motion. Motion carried.

The Redevelopment Commission met to approve Redevelopment claims. RDC Member Hoover made a motion to approve payment in the amount of \$150.00 to Eberhard & Weimber. RDC Member Mickem seconded the motion. Motion carried.

Discussion of the request to allow animals on a parcel of property on 200 N (South side, within Town Corp limits) began with asking Josh Pettit how many farm type animals he intended on having. Pettit stated that a maximum of 12 chickens and 2 horses. After discussing the proposal, Member Mickem made a motion to give a positive recommendation on behalf of the Pettits to the Board of Zoning Appeals, with a limit of 12 chickens and 2 horses, and only for this specific property owner. Member Bowser seconded the motion. Motion carried.

WASTEWATER: No Report

• Council asked the Town Manager if the question asked at the last meeting, "Why is the average use of the Sewer plant down by so much" had been answered. It appears to happen each year in the fall.
