The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

President Arroyo opened the meeting at precisely 7:00 pm.

Member Bowser made a motion to approve the agenda with flexibility, Member Mickem seconded the motion. Motion carried.

Marco Vian of Indiana Trails Community gave a presentation on biking/walking trails that have been proposed. The trail is to run from Ohio to Illinois. Safety, routes and other issues were discussed. - Presented site plans for All That Jazz, they are looking at 3 new buildings. Member Bowser made a
  motion to approve the site plan and move forward with the abatements. Member Hoover seconded the
  motion. Motion carried.
- Presented a proposed building plan for 719 N. Walnut. Member Naylor made a motion to approve the plans, Member Hoover seconded the motion. Motion carried.
- Presented tax abatement forms for Lake Area Designs and Yoder Wood Products, they are in compliance, Member Hoover made a motion to approve signing the paperwork. Member Bowser seconded the motion. Motion carried.
- o Looking a specs for a new truck for the Street Department.
- Discussed the proposed renovations for the Town Hall. There are issues getting a contractor to bid the
  work. The Town Manager is to continue looking, but bring to the council what information is gathered to
  the next meeting.
- o Will be attending INDOT ERC re-certification in Greenfield IN next week.

- Discussed 502 E Michigan Street. Member Hoover made a motion to send the property owner, Scott & Lisa Jordan a notice of hearing to appear at the meeting scheduled for April 18, 2016. Member Bowser seconded the motion. Motion carried.
- o Discussed ideas for summer activities in town.
