President Arroyo opened the meeting at precisely 7:00 pm.

Member Naylor made a motion to approve the agenda with flexibility, Member Bowser seconded the motion. Motion carried.

Council Member Bowser made a motion to approve minutes from the June 6, 2016 Regular meeting. Member Mickem seconded the motion. Motion carried.

WASTEWATER:

- Monthly Report for May 2016
- Received and discharged 11.971 mg of treated wastewater
- ❖ Average of 21% of design capacity
- ❖ Monthly reports completed and submitted to IDEM

Water:

- Council stated that the graph of water pumped looked similar to the wastewater graph previously submitted.
- ❖ All underground work is complete at Miller's Super Valu
- All approve meter purchases are in, two have been installed
- Gathering information regarding the purchase of equipment from the City of Ft Wayne
- ❖ 40,000 gallons of water weekly is used to flush dead ends and water towers

POLICE:

- Presented details reports for April & May 2016
- Gave commendation plaques to Deputy Nick Dubea and Ryan Stewart for a professional job during a home invasion in rural Howe. The residents, Mr & Mrs Phil Curtis were present to also thank the officers.
- Asked the council to consider bringing on another K9 officer. Deputy Bontrager had the K9 while employed in Shipshewana. Winda is a trained Jack Russell terrier. Member Hoover made a motion to approve the addition to the department. Member Bowser seconded the motion. Motion carried.
