Meeting Minutes - July 5, 2016

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Council Members Present: Juan Arroyo, Raymond Hoover, Suellyn Mickem, Edna Bowser, Deborah Naylor

Also present: Laurie Miller, Bill Eberhard

President Arroyo opened the meeting at precisely 7:00 pm.

The meeting was opened as a Redevelopment Commission to review claims. After a review, RDC Member Hoover made a motion to approve said vouchers, Member Mickem seconded the motion. Motion carried. Also discussed as the RDC Commission:

FIRE:

- Quotes to do the ladder truck certification: Mistras \$2.20 per foot; American Test Center did the testing on the old Ladder truck at \$1010.00 in 2014. Member Hoover made a motion to proceed with Mistras, Member Bowser seconded the motion.
- Hoover noted that the Chief contract would expire this year. It is the intent of the council (at this time) to advertise the position.
- Bill Connelly, LaGrange Publishing and Clay Township Trustee commended the fire department on a professional job with the Romer fire.
