Meeting Minutes - September 19, 2016

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Council Members Present: Juan Arroyo, Raymond Hoover, Suellyn Mickem, Edna Bowser, Deborah Naylor

President Arroyo opened the meeting at precisely 7:00 pm.

Member Edna Bowser made a motion to approve the agenda with flexibility, Member Deb Naylor seconded the motion. Motion carried.

Council Member Suellyn Mickem made a motion to approve minutes from the meeting. Member Bowser seconded the motion. Motion carried.

WASTEWATER:

- Waiting to install pump on the Culp lift station
- Received & Discharged 14.188 million gallons of treated wastewater
- Effluent flow averaged 0.458 MGD of 25% of design capacity
- Reports submitted to IDEM

Water

- Presented an adjustment form for Mary K Hicks 415 N Sherman St, noting multiple leaks in the crawl space, water soaked into the ground. (9000 gallons of water) – Member Mickem motioned to allow the adjustment, Member Bowser seconded the motion. Motion carried.
- Presented quotes for a High Service Pump as follows: Peerless Midwest \$10,900; Northern Pump & Well: 10, 994 & \$10, 250.00; Lane Northern \$#9630.50. Member Hoover made a motion to approve the purchase from Lane Northern, Member Mickem seconded the motion. Motion carried.

STREET DEPT:

- The Asset Management Plan of Streets is about 90% complete. The State may be doing another draw late in the year.
- Grinding Stumps, trimming trees & tree removal
- Getting ready for Corn School
- Assessed the skate board park for repairs. The skate park is closed for the time being.
- Repaired a storm drain at Wayne & High Streets INDOT did the final inspection on ST RD 9, they will be installing curb and gutter by Lake City Bank to help with erosion problems. They will also be working on a drain at SAS and cutting the square corners on Michigan & Lafayette Streets.
