President Arroyo opened the meeting at precisely 7:00 pm.

Council discussed several options, including new construction behind the Town Hall, including the possibility of making the Town Hall property part of the TIF district and using TIF funds to construct the new facility. The roof of the street department building is currently leaking and will need to be repaired regardless, as well as storage for salt is needed as soon as possible, as the previous building has been unusable for nearly 2 years. Member Mickem made a motion to award the complete bid to Regal Builders (both projects) as they are the lowest bid. Member Bowser seconded the motion. Motion carried with a unanimous vote.

 Requested permission for Brad Ringler and John Marlow to attend Street Sweeper maintenance school. Member Hoover motioned to approve the request, Member Naylor seconded the motion. Motion carried.

Town Manager:

- LaGrange Girls Youth league will be using the town park
- Cemetery staff will be testing a product that slows the growth of grass to lessen the need for trimming around gravestones as often
- Presented tax abatement filings for AquaZone, they are complete and in compliances. Member Bowser made a motion
 to approve and sign the forms, Member Mickem seconded the motion. Motion carried.
- Asked for approval for an Annexation Stipulation for Brent Frey on Grant Street Exended. Member Bowser made a
 motion to approve the stipulation agreement, Member Mickem seconded the motion. Motion carried.
- Discussed new annexation rules going thru the state legislature.

CLERK: Requested that the council consider re-establishing the Town's Cumulative Storm Sewer fund to prepare for future drainage repairs that may arise when doing street projects. Member Hoover motioned to approve the plan, Member Mickem seconded the motion. Motion carried.

ATTORNEY:

- Discussed different types of Tax Increment Financing districts, such as Tourism and Housing
- Will be contacting Parkview Hospital regarding the plan for sidewalks to the Town Hall.

OPEN DISCUSSION:

- Mike Cole asked about further plans for lighting along Townline Rd.
- Discussed the empty building south of Eberhard & Weimer and the renovations of the building to the north of the same business.
