Member Edna Bowser motioned to approve the agenda with flexibility, Member Deborah Naylor seconded the motion. Motion carried.

Council Member Suellyn Mickem made a motion to approve minutes from May 21, 2018. Member Naylor seconded the motion. Motion carried.

POLICE:

- Deputy Johnson has graduated Law Enforcement Academy
- Park vandalized last week. Discussed the vandalism and security cameras/system for the park. Member Hoover
 motioned to have the Town Manager secure quotes for a camera system, Member Bowser seconded the motion.
 Motion carried.
- Per previous meeting discussion, Member Hoover made a motion to move forward with budgeting for a sixth police officer for 2019. Member Bowser seconded the Motion. Motion carried with 3 yes votes and one member abstaining. Hoover, Naylor and Bowser voting yes, Mickem abstaining.
- Discussed personal use of police vehicles. Use would be limited to a 50 mile radius, from Townline Rd/US20. It is
 already addressed in the Police Standard Operating Procedures Manual. Member Hoover motioned to approve the
 personal use as noted in the Police SOP manual. Member Mickem made a motion to table the matter for a later
 meeting. (couple of months). Without a 2nd to his motion, Hoover then withdrew the motion made.

FIRE:
