Meeting Minutes: December 17, 2018

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Council Members Present: Juan Arroyo, Raymond Hoover, Suellyn Mickem, Edna Bowser, Deborah Naylor

Also present: Laurie Miller, Bill D. Eberhard, Jr

President Arroyo opened the meeting at precisely 7:00 pm.

Member Ray Hoover motioned to approve the agenda with flexibility, Member Deborah Naylor seconded the motion. Motion carried.

Council Member Naylor made a motion to approve minutes from December 3, 2018. Member Suellyn Mickem seconded the motion. Motion carried.

Holly Miller and Phil LaBrash of DLZ Engineering presented an agreement to design the Hawpatch Street Improvement Project. The group is asking for the council to give the Town Manager the authority to execute the agreements. Member Hoover motioned to approve granting the authority to LaGrange Town Manager, Mark Eagleson to submit INDOT agreements without council signature. Member Mickem seconded the motion. Motion carried. Miller then discussed the 2019 Community Crossing Grant application. Consensus of the council was to wait for the July submission.

WASTEWATER:

- Jeff Moore presented the council with a Monthly Report for November 2018
- No violations or overflows.

- Rehab of well #3 in process.

FIRE:

- Reported on fire calls for November
- Asked the council for a decision on 1st Responder pay for the fire department' fiscal year 2018. Member Hoover
 motioned to approve the 1st responder pay for this year, noting that there will be guidelines set forth to determine
 who should respond. The Town Attorney was directed to amend the 2011 Fire Pay Agreement. Member Mickem
 seconded the motion. Motion carried.

POLICE:

- Will be opening up the 6th officer position soon.
- Discussed the agreement with Deputy Todd Johnson. The Town Manager presented a stipulation agreement to release Johnson from his contract with the town. Member Hoover motioned to approve the stipulation, Member Bowser seconded the motion. Motion approved.

CLERK:

- Handed out a list of 2019 meeting dates
- Presented Resolution 2018.12.17 to reduce the 2018 Budget by \$24,000.00 in the Cumulative Capital Improvement Fund. Member Hoover motioned to approve the reduction, Member Mickem seconded the **motion. Motion**
