Meeting Minutes: July 3, 2023

The regular meeting of the LaGrange Town Council met at 6:00 pm, at the LaGrange Town Hall. (Also available via Zoom)

Council Members Present: Raymond Hoover, Diane Cameron, Josh Shotzman, and Edna Bowser

Also present: Laurie Miller, Charity Murphy, Mark Eagleson

President Hoover opened the meeting at precisely 6:00 pm.

Member Bowser motioned to approve the agenda with flexibility, Member Cameron seconded the motion. Motion carried.

Council Member Bowser made a motion to approve the regular meeting minutes from June 19, 2023; Member Cameron seconded the motion. Motion carried.

Andrew Yoder, LaGrange Leathers, requested street closing (Spring Street; from Detroit to High St) for July 15, 2023 from 2-6 pm for a fundraiser event. Member Bowser motioned to allow the closing, Member Cameron seconded the motion. Motion carried.

Tim Shoemaker, 306 Hillside Drive was present to discuss driveway and parking issues. Mr. Shoemaker presented a petition to ask the council to rescind the ordinance that prohibits parking in grass in town. Council accepted the petition and stated they would table the matter until a future date. Member Bowser requested a Public Hearing to discuss the issue with residents of town. The hearing was set for Monday, August 7, 2023 at 6:00 pm.

Member Bowser motioned to approve the request, Member Shotzman seconded the motion. Motion carried.
- Presented pay request #24 from Ottenweller Contracting in the amount of \$370, 324.20. Member Cameron
 motioned to allow President Hoover to sign the documents, Member Bowser seconded the motion. Motion carried.
- Attorney Eberhard made adjustments to the proposed sidewalk ordinance. A copy was presented. President Hoover requested the ordinance be tabled at this time.
