Council Members Present: Raymond Hoover, Carolyn Glick, Diane Cameron (via Zoom), Josh Shotzman, and Edna Bowser

President Hoover opened the meeting at precisely 6:00 pm.

Member Bowser motioned to approve the agenda with flexibility, Member Glick seconded the motion. Motion carried.

Council Member Glick made a motion to approve the regular meeting and the Executive meeting minutes from November 13, 2023; Member Bowser seconded the motion. Motion carried.
