The regular meeting of the LaGrange Town Council met at 6:00 pm, at the LaGrange Town Hall. (Also available via Zoom)

Council Members Present: Raymond Hoover, Carolyn Glick, Diane Cameron, Josh Shotzman, and Edna Bowser

President Hoover opened the meeting at precisely 6:00 pm.

Member Bowser motioned to approve the agenda with flexibility, Member Shotzman seconded the motion. Motion carried.

Council Member Glick made a motion to approve the regular meeting minutes from February 5, 2024; Member Bowser seconded the motion. Motion carried.

Sherri Johnston of the LaGrange County Economic Development Corp, presented a report of activities completed during 2023. She also updated council on goals and upcoming events.

Mary Woodworth, LaGrange County Arts, requested temporary closing of parking on W. Michigan Street, from Detroit St to High Street and on Detroit Street in front of the Courthouse for unloading of vendor goods for the Art show on June 29, 2024. Member Glick motioned to approve the closing of Michigan Street as requested, Member Shotzman seconded the motion. Motion carried. Member Glick also made a motion to allow Spring Street, from Detroit to High Street to remain closed following the Farmer's Market until 5:00 pm for the Art Show. Member Bowser seconded the motion. Motion carried. Woodworth gave an overview of Art Show events planned.

CLERK:

- Presented a quote from Boyce Systems to add trash billing to the utility billing software in the amount of \$500.00.

 Member Glick seconded the motion. Motion carried.
- Member Shotzman then made a motion to move forward with the purchase of 2 FLOCK cameras for the
 police department as discussed that the February 5th meeting from the Public Safety Fund. Member Glick
 seconded the motion. Motion carried.
