The regular meeting of the LaGrange Town Council met at 6:00 pm, at the LaGrange Town Hall.

Council Members Present: Raymond Hoover, Diane Cameron, Josh Shotzman, and Edna Bowser

President Hoover opened the meeting at precisely 6:00 pm.

Member Bowser motioned to approve the agenda with flexibility, Member Shotzman seconded the motion. Motion carried.

Council Member Bowser made a motion to approve the regular meeting dated June 17, 2024; Member Cameron seconded the motion. Motion carried.

CLERK:

- Discussed the purchase of picnic tables for the new area by the splash pad. Several prices and styles were discussed, however due to the cost, the council asked that local vendors be sought out.

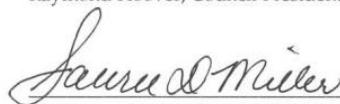
OPEN DISCUSSION:
