Meeting Minutes: March 3, 2025

The regular meeting of the LaGrange Town Council met at 6:00 pm, at the LaGrange Town Hall. (Also available via Zoom)

Council Members Present: Raymond Hoover, Carolyn Glick, Josh Shotzman, and Edna Bowser

Also present: Laurie Miller, Mark Eagleson, Bill Eberhard, Jr

President Hoover opened the meeting at precisely 6:00 pm.

Member Bowser motioned to approve the agenda with flexibility, Member Shotzman seconded the motion. Motion carried.

Council Member Bowser made a motion to approve the regular meeting dated February 17, 2025; Member Shotzman seconded the motion. Motion carried.

Mark Eagleson, President of the LaGrange Redevelopment Commission opened discussion for the proposed sale of property commonly known as the "Corner of State Rd 9 (Detroit Street) and US 20 (Central Avenue). One (1) sealed bid was received as an offer of purchase. Eagleson opened the document and noted that an offer of \$372,000.00 was received from Haidous Estates, Talal Haidous. Member Ray Hoover made a motion to give a favorable recommendation to the Town of LaGrange to accept the bid. Member Glick seconded the motion. Motion carried.

Ray Hoover, Council President then discussed the proposed sale with the Town Council members. Member Glick made a motion to approve the sale of the property to Haidous Estates, Talal Haidous for \$372,000.00. Member Bowser seconded. Motion carried.
