Meeting Minutes: April 7, 2025

The regular meeting of the LaGrange Town Council met at 6:00 pm, at the LaGrange Town Hall. (Also available via Zoom)

Council Members Present: Raymond Hoover, Carolyn Glick, Josh Shotzman, Edna Bowser and (Diane Cameron via zoom)

Also present: Mark Eagleson, Bill Eberhard, Jr

President Hoover opened the meeting at precisely 6:00 pm.

Member Glick motioned to approve the agenda with flexibility, Member Bowser seconded the motion. Motion carried.

Council Member Bowser made a motion to approve the regular meeting dated March 17, 2025; Member Shotzman seconded the motion. Motion carried.

Jenny Landez, Main Street LaGrange ask the council for permission to close Spring Street and park food truck on Detroit Street in from of the Courthouse on May 30, June 27, July 25 and August 29 from 6 to 9 pm for the Main Street Final Fridays Events. Member Glick motioned to approve the request; Member Bowser seconded the motion. Motion carried. Mrs. Landez then updated the council on Main Streets marketing plans and their planned Raffle fundraiser as a part of this year's Final Fridays Events. She also ask the Council if they would consider a sponsorship of the costs of having law enforcement present at their events. The matter was table until further research could be done.

Holly Miller, DLZ, then explained to the Council the content of Change Order Number 2 and Final regarding the Town's contract with Ottenweller Contracting LLC for the construction of the New Water Treatment Plant and Well Number 5. Member Glick made a motion to approve and authorize Council President Hoover to sign; Member Bowser seconded the motion. Motion carried.

CLERK:

Ask Council for guidance on how they wanted to proceed with providing citizens with drinking water filters regarding the Town's Lead Line replacement plan now that the original purchased filters have been almost depleted. After some discussion Member Glick made a motion to purchase additional filters which the Town will continue to provide until January 1, 2026. Said motion further requires that any citizen receiving a filter be made award of the deadline and sign a Notice of the same. Member Bowser seconded the motion. Motion carried.

Next the Council discussed purchasing banners for the Second Saturday Events at the Park this year. Member Glick made a motion to purchase 5 banners in an amount not to exceed \$1,500.00. Member Bowser seconded the motion. Motion carried.

Water: Report of work completed provided.

Wastewater: No report was given

Street: Report of work completed provided. Street Supervisor Marlow presented three quotes for adding Mulch at the Park. Member Glick made a motion to approve the quote from Worx Companies for \$4,250.00. Member Shotzman seconded the motion. Motion carried.

Cemetery: Report of work completed provided

Park: Town Manger Eagleson advised the Council that the Youth Baseball League has started using the ballfield this week and requested permission to have a portable toilet placed by the ballfield. After some discussion, Member Glick made a motion to have Avail place potable toilet at all of the same location at the park as in previous years. Member Shotzman seconded the motion. Motion carried.

Police: Provided March Activity Report. Marshal Snyder ask that the Council approve the updated Use of Force and Emergency Driving and Vehicle Pursuits SOP Policies and Procedures. Member Bowser made a motion to approve the updates. Member Shotzman seconded the motion. Motion carried.

TOWN MANAGER:

Presented Site Plans for the purposed new Dairy Queen, MJM Improvement Housing Development and new Five Lakes Coffee Building. Discussion was held, Council directed Town Manager Eagleson to prepared letters of the Council's findings on the preposed projects for the LaGrange County Plan Commission.

Fire - No report was given.

ATTORNEY: Provided a draft Ordinance of Park Rules. Discussion was had. Attorney will work with the Marshal and Town Manager on the purposed changes.
