The regular meeting of the LaGrange Town Council met at 6:00 pm, at the LaGrange Town Hall.

**Council Members Present:** Raymond Hoover, Carolyn Glick, Diane Cameron, Josh Shotzman, and Edna Bowser

President Hoover opened the meeting at precisely 6:00 pm.

Member Bowser motioned to approve the agenda with flexibility, Member Shotzman seconded the motion. Motion carried.

Council Member Bowser made a motion to approve the regular meeting dated April 7, 2025; Member Shotzman seconded the motion. Motion carried.

Andrew Yoder, LaGrange Leathers requested a street closing to accommodate 75-100 Bikes for August 16<sup>th</sup> for a Benefit Bike Ride from 11:30 – 12:30. Member Glick motioned to approve the closing, Member Cameron seconded the motion. Motion carried. Yoder will need to work with the Town Manager and Street Dept to determine which areas should be closed.

Jonas Miller, planning to construct a storage building behind the Town Hall, will create 3 new jobs. Member Shotzman made a motion to approve the construction using a septic system for the building for the current project, if the building expands to include more than one restroom and kitchenette, or adds more than 10 additional employees, they would need to connect to municipal sewer. Member Glick seconded the motion. Motion carried.

Solar Freeze LLC - Member Bowser motioned to approve, Member Cameron seconded. Motion carried.


**ATTORNEY:** Updated Council on various projects
