## LaGrange Town Council Meeting

Monday, August 4, 2025

**Present:** Raymond Hoover, Carolyn Glick, Diane Cameron, Edna Bowser, Laurie Miller, Mark Eagleson, Bill Eberhard, Reagan Penick.

The meeting began with Member Bowser motioning to approve the agenda, Member Cameron seconded. Motion carried. Member Bowser then motioned to approve the minutes from July 21, 2025, seconded by Member Glick. Motion carried.

**Clerk Treasurer Miller** discussed purchasing fall banners for the downtown corridor.

**Town Manager Eagleson** presented pay app #3 for ClearCreek Coatings (Water tower project), in the amount of \$148,579.98. Member Glick motioned to approve signing off on and paying the pay application as presented. Member Bowser seconded. Motion carried.

Eagleson then presented Ordinance #2025-08-04(A) titled "Town of LaGrange Employee uniform policy"; after discussing the policy, Member Glick made a motion to approve the ordinance for first reading only. Member Bowser seconded the motion. Motion carried. Eagleson will meet with the employees to review the document and report back to the council.

### Department Reports:

Updates were shared on various town projects including budget matters, street work, cemetery operations, and upcoming events, along with discussions about town council business including project approvals and employee handbook adoption. The conversation ended with updates on legal matters, park projects, and utility work, followed by the approval of claims and adjournment.

### Open Discussion:


