

Meeting Minutes May 31, 2011

Opening:

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

Council Members Present: Mark Eagleson, Terry Helmer, Richard Greene, Bruce Eagleson, Gene Potter, Mike Rowlison, Clerk, Bill Eberhard

President Helmer opened the meeting as a Public Hearing for the GIS Planning Grant. Kristine Christlieb of Region 3A was present to conduct the hearing.
