

Meeting Minutes - September 4, 2012

## Opening:

The regular meeting of the LaGrange Town Council met at 7:00 pm, at the LaGrange Town Hall.

**Council Members Present:** Mark Eagleson, Ray Hoover, Bruce Eagleson, Bill Eberhard Laurie Miller, Greg Kenner

Absent: Richard Greene

Council Member Richard Greene made a motion to open the regular meeting with flexibility, Member B. Eagleson seconded the motion. Motion carried.

Council Member G. Kenner made a motion to approve minutes from the August 20, 2012 meeting, Member B. Eagleson seconded the motion. Motion carried.

<u>WASTEWATER-</u> The catwalks have been power washed and painted. Reported that the new roof should be done within 2-3 weeks. Member Hoover stated that he visited the plant and took a tour. He encouraged other members that have not seen the plant to do so.

<u>Water:</u> Thanks Officer Evans for helping with a issue. Working on getting a hydrant map around for the Fire Dept. Requested permission to attend a class in Goshen. Member Kenner made a motion to approve the class, Member B. Eagleson seconded the motion. Motion carried.

Hydrant flushing will begin in late September, the schedule will be published in the newspaper and website. Located water lines for the Hospital and other areas.

Discussed why there was water running in a drain on Lafayette St (possibly a storm drain) even during a drought.

**FIRE**: Displayed the Fire Safety House at the LaGrange Road Race and Prairie Heights concert. Forks RV has updated and repaired the Safety House at no cost. They have offered to do an inspection and updates yearly.

1st Repsonder training was held at the station tonight. Received animal recitation equipment from Brian Cochran from ARC animal rescue.

**POLICE**: New police car is in and will be picked up this week.

**Street Dept:** Received quotes for crack filling at the park. CM Asphalt \$500.00 and Homer's Services \$750.00. Member Hoover made a motion to have CM do the work. Member Eagleson seconded the motion. Motion carried.

Hall Signs quoted the "protect our children and pets" signs at \$33.10. The Dept would like to purchase 12 of the signs. Member Hoover made a motion to do so, Member Kenner seconded the motion. Motion carried.

The dept responded to a sewer line issue on Pleasant Lane. It has been an ongoing problem area, the dept would like to have a camera come in and scan the area to see what needs to be done. They were asked to bring in a list of other problem areas for the next meeting.

Wilson Road Service repaired the Rodder. They made a list of equipment and repairs that were going to be needed. The cost would be approx. \$2300.00. Member Kenner made a motion to do all the repairs and equipment recommendations. Member Hoover seconded the motion. Motion carried.

Discussed whether the town has a grass clipping ordinance.

Discussed changing parking to one side of the street only on Union St, from Miller's Alley to Hawpatch. Member Kenner made a motion to move forward with the parking change. Member Eagleson seconded the motion. Motion carried.
