- II. Public Budget Meeting Called to Order
 - a. Clerk Treasurer read the budget for 2026
 - i. No questions from the audience or council at this time; Meeting adjourned
- III. Regular Town Meeting Called to order
- IV. Roll Call
 - a. Council President Shelton—Present
 - b. Councilwoman Fox—Present

- V. Resident Concerns
 - a. Mary Ross stated her water has a lot of rust in it here lately. Scott stated they will be flushing hydrants in a few weeks and it should clear up.
 - b. Beth Gillespie asked if the board heard anything about TIF going away in 2027. Kristie stated she had not but would look into this.
- VI. Clerk Report--Kristie
 - a. Kristie stated that the transfers from the old computer to the new computers has not gone as smooth as she would have liked. VC3 did not do the job correctly and therefore she is having to call in BIT Computers to fix the job. In the mean time billing software is down for both computers and the printer is down for both computers. Kristie spoke with Kristin from VC3 and she stated for Kristie to send her the bill for BIT and she would see if she could get it reimbursed.
 - b. Kristie asked legal counsel his thoughts on the American Publishing Ordinance book. He stated it was just very vague and the town ordinance need to be in there. Kristie stated she will get back with them and get clarification on this.
 - c. Kristie will be out next week for training however Cindy will be here.
- VII. Water Report—Andrew
 - a. Andrew stated that 524 (Bluestar Hwy) needs some immediate attention as far as trees and trash being cleaned up. He stated that Tipton St & Harriett St also need attention. He is going to start with 524 and get it cleaned up. He will be renting a skid steer and Council President Shelton offer to help with the cutting and clean up as well.
 - b. Andrew state that the properties of Roger Red and Jason Harlan need to be addressed. We have had complaints about junk and yards at these places. Council President Shelton requested that Clerk Treasurer send out a letter to the property owners on this issue. Legal counsel suggested to add in the letter they are welcome to contact either Andrew King or Jeff Shelton Council President if they have questions or concerns about the letter they receive.
 - c. Andrew gave an update on the Kerr Locks Memorial. The Park Board has raised their share and will get a \$15,000 match from IHCD.
