**\*\*Clerk Report\*\***

1. Kristie stated that Cindy is now a certified PSAR grader. Certification is good for 2 years and is required to get an CCMG Paving Grant now.
2. Town of Lagro was awarded the CCMG grant Kristie applied for!
3. Kristie was sent an Easement agreement from the county for Nick Palmers property. His shed, porch, and half his house is on town right away. Joe will fill out the paperwork so the council can sign off on it.
  - a. Councilwoman Fox made a motion to allow for the easement once legal counsel has filled out the papers properly on the town's behalf.

Kristie stated that Marion is as well starting this tax. Kristie checked with the county and due to the wheel tax at this time they are NOT pursuing this tax.
