October 2, 2024 Minutes

Arthur called the meeting to order at 5:00pm

The pledge to the flag and Lord's pray followed.

Next on the agenda was the Public Hearing for Sewage rates presented by Steve Brock. He stated that the rates were prepared in July for utilities. They need to be looked at periodically. The town has a budget every year, but the utilities only get looked at when rate studies are done. The last one was 2016 for the utilities budget. IC 36 states expenses and cost are fair and reasonable. The fund is for maintenance, repair, and debts. His current suggestion was to raise the rate 36%. He said he was here to answer questions. There was a public notice, and it had its first reading in August. Rob said when Steve was here previously, he explained the rate increase. Steve said in 2023 lost \$50k in spending more than brought in. Inflation was the main cause of this. The 2022 year we lost \$3k. Mark Moody how much of the rate can we cut. Steve went through the process of figuring out where the rates needed to be. He stated the rate increase would break even and a little extra for longevity until the next study. Steve said this was on a 3-year plan that way he doesn't have to do a study every year. He said costs are looked at every month by the board and the superintendent to determine if costs can be cut. Right now, there is nowhere to cut. Mark asked how many people don't pay their bills. Steve said when bills aren't paid that the town files liens on the property that get paid at tax time. He stated the town does a good job of collecting. Mark stated we keep doing these studies and raising rates and some need help. Steve said there are ways to cut costs personally. Arthur said we don't want to see the increase, but we need it. Robert asked about private companies buying utilities. Steve said that private companies would love to buy our utilities, but it ends up costing the consumers more in the end. Steve said it looks good on paper but not in reality. He stated it was not a good option for the town and once it is sold it can't be bought back.

Robert Made the Motion to close the public hearing. Barbara second the motion. Motion was carried all in favor.

Suzan read ordinance 2024-3.

Jonathan stated that Shannon Retter would like to wait until after the first of the year to revisit this. Suzan stated if that was the case this would not be able to happen until 2026 as March is the cut off.

Suzan then stated she had the ordinance and the permit for the Bees. There is a statute stating we can't prohibit bees so this ordinance would be an appealing ordinance 2006-1. With the permit the Marshal would visit the property to make sure they meet all guidelines.

Michael stated we are having an audit. The board should have received an email and need to complete it as soon as possible. The audit has brought a couple of things to our attention, and we would like Suzan to look at a new ordinance for capital assets. Right now, it is anything over \$1,000, other towns are at \$5,000 and we would like to raise ours. Michael also stated he would like Suzan to look into an ordinance where rate studies are done every 3 years. So, we don't run into a huge jump in rates like we are going through now.

Arthur called for employee information. Brad stated the two radar signs have been installed. One on W Church and one on S Main St. There was a lot of red tape that had to be gone through for the one on Main St. and they will be here within the next 7 days for inspection.

Brad stated the alleys have been paved and the claim has been given to the clerk's office. They did a really good job and will probably be used more in the future.

Brad then stated that the Court date for Mark Marquis has been set for December 2nd.
