I/WE agree to abide by the following rules and regulations governing use of town parks from the Montezuma Municipal Code 7-2-8.

The rules and regulations herein provided for are intended to be effective in all public parks, parts thereof, and park facilities of the Town of Montezuma unless otherwise expressly provided hereinafter, and such rules and regulations are intended to provide for the improvement, preservations, and management of such parks and their facilities. The following rules and regulations apply:

- a. The operation of all vehicles in such parks, except in designated parking areas, is hereby forbidden, except as the operation of vehicles therein may be authorized by the Montezuma Park Board and the Town Council of the Town of Montezuma.
- b. The parking of vehicles in all parks shall be restricted to designated parking areas only.
- c. The presence of bicycles and horses on baseball diamonds, tennis courts and basketball courts in the parks is forbidden
- d. The use of glass containers in the parks is forbidden.
- e. Instructions on all legally posted signs in the parks shall be obeyed.
- f. NO ALCOHOLIC beverages or controlled substances shall be brought into, used, consumed, sold, or traded in such parks at any time.

Any person convicted of the violation of any of the terms of this section shall be fined not exceeding \$ 50.00 which may be recovered in an action in the name of the Town of Montezuma.

2. All trash will be picked up from the park grounds and placed in the proper trash receptacles in the park. All park equipment will be returned to the location in the park in which it was found. I/We accept responsibility for removal from the park of any trash not contained in proper receptacles.
3. I/We agree to leave the park in same condition as it was prior to commencement of this agreement.
4. I/We agree to indemnify, release and hold harmless said Town, it's employees assigns and insured from any and all damages or injuries incurred as a result of our use of town property.
