Festival Country Indiana

Ken Kosky shares the 2021 Annual Report along with the 2022 Activities Guide. He reports that since the last time he was here, they have opened a Visitor's Center in downtown

Franklin. They served 543 visitors last Saturday, July 3rd. Kosky reports that tourism in Johnson was down 15% last year due to the pandemic. However, he notes Marion County was down more than 80%. Kosky states that his office is ready and willing to assist in anyway possible with helping find grants to fund projects that are not available elsewhere in the county. They will also help promote any future events we plan.

They are currently partnering with Johnson County Parks on a military themed obstacle course. They are looking for host sites and funding for an ice-skating rink and a mountain bike course.

LEGISLATIVE BUSINESS

Ordinance 2021-04

President Perrin reads the ordinance in title only on final reading. Motion to adopt Ordinance 2021-04 by Councilman Waltz on final reading and seconded by Councilman Schilawski. Vote 5 affirmative.

Resolution 2021-03

Attorney Robbins presents a resolution stating that New Whiteland approves our participation in the Community Crossing Grant program and authorizing Council President John Perrin to sign all required documents. Motion to approve Resolution 2021-04 by Councilman Vaughn with second made by Councilman Alspach. Vote 5 affirmative.
