Plan Commission

This budget is approved with an overall increase of \$694 to a total of \$98,703.

Wastewater

The budget is approved with an overall reduction of \$14,207 to a total of \$1,162,809.

Storm Water

The budget is approved with an overall reduction of \$6,959 to a total of \$330,195.

Properties

This budget is approved with an overall reduction of \$33,705 to a total of \$135,732.

Parks

This budget is approved with an overall reduction of \$25,000 to a total of \$63,000.

MVH

All salaries were removed from the MVH budget in 2024 and split between the Wastewater, Storm Water, Plan Commission, and Properties budgets. This allows 100% of the MVH funds to be used for road repairs.

This budget is approved with an overall reduction of \$216,204 to a total of \$299,125.

Police

This budget is approved with an overall reduction of \$8,984 to a total of \$983,148.

Fire

This budget is approved with an overall reduction of \$2,800 to a total of \$267,160.

Town

This budget is approved with an overall reduction of \$6,371 to a total of \$754,610.
