STANDARD CONDITIONS:

- MATERIALS SHALL NOT BE STOCKPILED WITHIN THE PUBLIC RIGHT-OF-WAY.
- 2. WORK MUST COMMENCE ON THE DATE SUBMITTED ON THE APPLICATION. IF NOT SO COMMENCED, THE PERMIT SHALL AUTOMATICALLY TERMINATE UNLESS AN EXTENSION OF TIME IS OBTAINED. THE PERMIT SHALL EXPIRE ON THE ESTIMATED DATE OF COMPLETION SPECIFIED ON THE PERMIT.
- 3. CONTRACTOR SHALL ATTACH A \$15,000 (MINIMUM) LICENSE/PERMIT BOND FOR A SINGLE LOCATION OR BLANKET BOND. SUBJECT TO EVALUATION OF SCOPE OF PROJECT BY PUBLIC WORKS SUPT. CASH DEPOSIT IS NOT AN OPTION FOR CONTRACTOR.
- 4. A PERMITTEE SHALL PROVIDE PROOF OF GENERAL LIABILITY INSURANCE IN THE AMOUNT NOT LESS THAN \$1,000,000.
- 5. IF THE APPLICANT IS USING ANY SUBCONTRACTORS TO COMPLETE THE PROJECT, THEY MUST MEET THE SAME SECURITY REQUIREMENTS AS OUTLINED ABOVE.
- 6. AT ALL TIMES WHILE WORK IS IN PROGRESS, THE PERMITTEE SHALL MAINTAIN AT THE JOB LOCATION A SIGN, BARRICADE OR OTHER DEVICE BEARING THE PERMITTEE'S NAME IN SUCH A MANNER THAT IT IS CLEARLY VISIBLE.
- 7. ALL OPERATIONS OF THE CONTRACTOR, INCLUDING THOSE OF TEMPORARY NATURE, MUST BE CONFINED WITHIN THE APPLICABLE R.O.W LIMITS.
- 8. IF THE METHODS OF CONSTRUCTION REQUIRE THE USE OF LAND BEYOND R.O.W LIMITS, CONTRACTOR SHALL MAKE THEIR OWN ARRANGEMENTS WITH THE PROPERTY OWNERS FOR USE OF SUCH LAND AND WILL NOT INCLUDE ANY LIABLITY FOR THE TOWN.
- 9. OWNER OR OWNER'S AGENT SHALL PROVIDE AN EROSION CONTROL PLAN FOR REVIEW AND APPROVAL BY UTILITIES SUPT.
- 10. IF A LANE RESTRICTION IS APPROVED, ADVANCE NOTIFICATION TO ALL ENTITIES INCLUDING BUT NOT LIMITED TO FIRE DEPT., POLICE DEPT, TRASH COMPANY & SCHOOL CORPORATION IS REQUIRED. IF LANE CLOSURES ARE REQUIRED, YOU MUST OBTAIN PERMISSION FROM THE PUBLIC WORKS SUPT.
- 11. A MAP OR SKETCH AND OTHER SUPPORTING DOCUMENTATION SHALL BE SUBMITTED TO THE PUBLIC WORKS SUPT., UTILITES SUPT., CODE ENFORCEMENT DEPT. FOR REVIEW AND APPROVAL AT LEAST TEN (10) BUSINESS DAYS PRIOR TO ANTICIPATED START OF WORK.
- 12. ALL WORK MUST BE INSPECTED. INSPECTIONS MUST BE SCHEDULED AT LEAST 24 HOURS IN ADVANCE. APPROVAL OF THIS PERMIT ALLOWS WORK TO BE DONE ONLY DURING THE HOURS OF 7:00 A.M. TO 7:00 P.M., MONDAY-FRIDAY, UNLESS OTHERWISE APPROVED BY THE PUBLIC WORKS SUPT.

13. THE OWNER/APPLICANT SHALL BE ULTIMATELY RESPONSIBLE TO ENSURE THAT COMPLIANCE WITH ALL APPLICABLE LAWS, PERMITS, REQUIREMENTS AND REGULATIONS IS ACHIEVED ON THIS PROJECT.
