They will be tiered permits and we will be the smallest tier with fairly minor changes. Tiers are by population.

He is hoping to have it back by Friday.

Carlson Corners-It will be a 4 week project and should start next Wednesday. Spanier has Sechrist looking for places to put the message board about road closures.

Pond at Porter Ridge-Porter Count will convey it to us but it will not be until next spring.

There is a lot of overgrowth and the biggest issue is getting to the pipes.

Old Business-Notice to Proceed-North Bailey and Carlson Corners-Mr. Lopez made a motion to sign the Notice to Proceed for North Bailey and Carlson corners, Mr. Reynolds seconded. Motion passed 3-0.

New Business-He has a few complaints he is checking into.
