We will need a mission statement to apply for grants. We will make statement of pieces of paper to suggest what our ideas are for a mission statement. Date for the workshop will be September 17, it will be open to public though not for the public. We need smaller projects rather than policy after policy. Tara Duffie states our end goal is to make a difference, be better organized and apply for grants.

Kimberly Ehn-American Bird Conservancy's Cats Indoors Program-Kimberly states she has been working on the town's recertification application for the Bird City network and trying to implement old application into the new application. The new application has a section on threats to birds. She found in Town Code Supp 16 Sec 10-32 Leash regulations. No person being owner of any dog or cat shall permit or allow to run at large in the streets, or on the walks or public grounds of the town unless on a leash. She

would like us to put a link on our website with more information. Once application is approved we will be live on Bird city website. She also suggests that Town Parks description be updated to sound more bird friendly.

G. Comments from Floor-Jenny Dimitroff gives a little rundown on neighborhood walk. She suggests walk around and look at new gardens and talking about things people can do in their own back yard. Kim Ehn mention maybe include birds on walk.
