The Porter Police Commission was called to order at 6:04 p.m.

Appointment of Officers and Secretary

Lynk made a motion to appoint Huckaby as President, Gruett made second. Motion passed 2-0.

Gruett made a motion to appoint Lynk as Vice President, Lynk made second. Motion passed 2-0.

Lynk made a motion to appoint Sufana as Recording Secretary, Gruett seconded. Motion passed 2-0.

Officer Rospierski recently completed a rigorous course and is now certified as a Drug Recognition Expert. In Porter County there are only 4 DRE certified Officers our department has 3 of those 4 Owens, Rospierski, and Blythe.
