

ORDINANCE 2002-2

TOWN OF REDKEY, INDIANA

AN ORDINANCE FOR THE REGULATION OF PARKING ON HIGH  
STREET BETWEEN MERIDIAN STREET AND OAK STREET

BE IT ORDAINED by the Town Board of Redkey, Jay  
County, Indiana

THAT:

Section I: The purpose of this ordinance shall be to facilitate the flow of traffic and the orderly parking of vehicles on the North side of High Street from Meridian Street to Oak Street.

Section II: For the purpose of this ordinance the following definitions shall apply unless the context of ordinance clearly indicates or requires a different meaning.

(a) Vehicle: For the purposes of this ordinance a vehicle shall be any form of conveyance that is self-propelled including but not limited to automobiles, trucks of all duty ratings, motorcycles, motorized bicycles, or all terrain vehicles.

(b) Owner: For purposes of this ordinance the owner of a vehicle shall be the last known record title holder of a vehicle according to the records of the Indiana Bureau of Motor Vehicles.

Section III. From the date of the adoption of this ordinance and thereafter parallel parking shall be prohibited on the North side of High Street between Meridian Street and Oak Street.

Parking shall be permitted only within designated parking spaces and in a fashion commonly known as angle parking, provided however that no vehicle exceeding twenty (20) feet in length, said length to be measured from the furthest point at the front of said vehicle to the rearmost point of said vehicle to the rearmost point of said vehicle including any trailers or attachments thereto, shall be permitted to park within the above said designated parking space.

Section IV: From and after the date of adoption of this ordinance shall be subject to a fine of ten dollars (\$10.00) for violation of the ordinance with the fine being twenty-five dollars

(\$25.00) for each second and subsequent violation of the ordinance by the same owner.

Section V: The owner of a vehicle parked in contravention of this ordinance shall be deemed to commit a separate violence for each twenty-four (24) hour period during which time such vehicle is parked unlawfully.

Section VI: Upon the passage of this ordinance the Town of Redkey shall cause to be clearly marked upon the North side of High Street between Meridian Street and Oak Street lines to indicate areas wherein angled parking is permitted pursuant to this ordinance, said lines to comply with all applicable local, state and federal regulations.
