

ORDINANCE 2008-1
SALARY ORDINANCE

SECTION I:

Be it ordained by the Town Council of the Town of Redkey that the Town positions and the salaries and the salaries and wages for said positions shall be as follows and payable as scheduled below:

TOWN COUNCIL MEMBERS(5):

The Town Council Members shall receive \$1,200.00 each, payable from the General Fund

CLERK TREASURER:

The Clerk Treasurer shall receive:

\$13,484.00 from the General Fund

\$ 5,680.00 from the Water Operating Fund

\$ 5,680.00 from the Sewage Operating Fund

Total salary payable to the Clerk Treasurer shall not exceed \$24,844.00

TOWN MARSHAL:

The Town Marshal shall receive:

\$27,887.00 payable from The General Fund

\$ 1,445.00 Payable from the Motor Vehicle Highway Fund

Total salary payable to the Town Marshal shall not exceed \$29,332.00

DEPUTY MARSHAL(2):

The Deputy Marshal shall receive:

\$24,785.00 payable from the General Fund

\$ 1,853.00 payable from the Motor Vehicle Highway Fund

Total salary payable to the Deputy Marshal shall not exceed \$26,638.00

STREET AND MAINTENANCE SUPERINTENDENT:

The Street and Maintenance Superintendent shall

receive:

\$11,808.00 payable from the Motor Vehicle
Highway Fund
\$13,425.00 payable from the Water
Operating Fund
\$ 1,525.00 payable from the Sewage
Operating Fund
The salary payable to the Street and Maintenance
Superintendent shall not exceed \$26,758.00

WATER SUPERVISOR AND WASTEWATER SUPERINTENDENT:

The Water Supervisor and Wastewater Superintendent
shall receive :

\$9,405.00 payable from the Motor Vehicle
Highway Fund
\$5,000.00 payable from the Water Operating
Fund.
\$14,895.00 payable from the Sewage
Operating Fund
The salary payable to the Water Supervisor and
Wastewater Superintendent shall not exceed
\$29,300.00

OFFICE ASSISTANT:

The Office Assistant shall be paid \$8.00 per hour
not to exceed:

\$3,662.00 payable from the General Fund
\$3,661.00 payable from the Water Operating
Fund
\$3,661.00 payable from the Sewage Operating
Fund
Total salary payable to the Office Assistant shall
not exceed \$10,984.00

PART-TIME LABORER:

Part-Time Laborer shall receive \$12.00 per hour
payable from the
Motor Vehicle Highway Fund
Water Operating Fund
Sewage Operating Fund
Payment for part-time laborer shall be made from
the appropriate fund based upon duties performed

SECTION II:

The Town Council Members shall be paid at the end of each quarter except for the last quarter. Payment for the last quarter shall be made by the last regular council meeting in December.

SECTION III:

The Water and Wastewater Superintendents shall receive an additional \$500.00 salary increase for each certification test successfully passed.

SECTION IV:

Full time employees and the Clerk Treasurer shall be eligible for health insurance provided by the Town

SECTION V:

Except as noted, said employees and elected positions shall be paid on a weekly basis. Each pay period shall end on Thursday. Paychecks shall be issued on Friday.

SECTION VI:

This ordinance shall be effective January 1, 2008 through December 31, 2008
