ORDINANCE NO. 2012-2 ANNEXATION ORDINANCE

WHEREAS, the boundary of the Town of Redkey, Indiana is contiguous to the real estate described herein, and

WHEREAS, a Petition For Annexation Into The Town of Redkey, Indiana was filed by all of the owner of said real estate requesting annexation of the area pursuant to Indiana Code § 36-4-3-5.1.

NOW THEREFORE, BE IT HEREBY ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF REDKEY, JAY COUNTY, INDIANA, That:

Section 1. The following described real estate be, and the same is, hereby annexed to and declared a part of the Town of Redkey, Jay County, Indiana, to-wit

Commencing at a point fifty (50) feet north and fifty (50) feet east of the northeast corner of Lot numbered ten (10) in McKennet's Addition to the Town of Redkey, Indiana; thence east one hundred forty (140) feet; thence south four hundred ninety seven (497) feet to the north line of the right-of-way line of State Road No. 67; thence west on and along the said north line of said right-of-way one hundred forty (140) feet to the east line of Spencer Street in said Town of Redkey, Indiana; thence north on said east line four hundred ninety seven (497) feet to the place of beginning, and containing one and six tenths of an acre more or less.

A strip of land twenty (20) feet wide off of and along the entire south side of the above described land is hereby conveyed subject to an easement heretofore granted to the State of Indiana for highway purposes.
