TOWN OF REDKEY, INDIANA ORDINANCE 2013-_//_

An Ordinance For the Regulation of Parking on Main Street at the Intersection of Meridian Street

BE IT ORDAINED BY THE COMMON COUNCIL, OF THE TOWN OF REDKEY, JAY COUNTY, INDIANA THAT:

Section I: The purpose of this ordinance shall be to facilitate the flow of traffic at the intersection of Main Street and Meridian Street and the orderly parking of vehicles on the Northeast corner of Main Street at Meridian Street.

Section II: For the purpose of this ordinance, the following definitions shall apply unless the context of the ordinance clearly indicates or requires a different meaning.

- Vehicle: For the purposes of this ordinance, a vehicle shall be any form of conveyance that is self-propelled including but not limited to automobiles, trucks of any size, motorcycles, motorized bicycles or all-terrain vehicles.
- Owner: For purposes of this ordinance, the owner of a vehicle shall be the last known record title holder of a vehicle according to the records of the Indiana BMV.

Section III: From the date of the adoption of this ordinance and thereafter, parking shall be prohibited on the north side of Main Street from Meridian Street to fifty-five feet (55') east of Meridian Street.

Section IV: From and after the date of adoption of this ordinance, owners found in violation of this ordinance shall be subject to a fine of Ten Dollars (\$10.00). The fine shall be Twenty-five Dollars (\$25.00) for each second and subsequent violation of the ordinance by the same owner.

Section V: The owner of a vehicle parked in contravention of this ordinance shall be deemed to commit a separate violation for each twenty-four (24) hour period during which time such vehicle remains unlawfully parked.

Section VI: Upon the passage of this ordinance, the Town of Redkey shall cause the area beginning at the northeast corner of the intersection of Main Street and Meridian Street thence east fifty-five feet (55') to be clearly marked to indicate the prohibited parking area.

This Ordinance was duly passed in regular session of the Town Council of the Town of Redkey, Jay County Indiana, on this 21 day of November 2013.
