ORDINANCE 2017-4

An Ordinance For the Regulation of Parking in the Town of Redkey, Indiana

WHEREAS, The Town of Redkey desires to unify and regulate the parking regulations for the Town of Redkey, Indiana;

WHEREAS, The Town of Redkey wishes to amend and unify Ordinance 2002-2, 2013-11, and 2015-~~8~~;

BE IT ORDAINED BY THE TOWN OF REDKEY, JAY COUNTY INDIANA:

A. No person shall stop, stand, or park a vehicle, except when necessary to avoid conflict with other traffic or incompliance with the law or the response to the directions of a police officer or a traffic control device, in any of the following places:

I. On a sidewalk or with any wheel upon or outside the curb where curbs exist;

II. In front of a public or private driveway;

III. Within an intersection;

IV. Within 15 feet of a fire hydrant;

V. On a crosswalk;

VI. Opposite the flow of traffic;

VII. At any place where official signs prohibit parking or stopping; and, at any place designated in the attached schedule of prohibited parking areas.

B. From and after the date of adoption of this Ordinance, owners found in violation of this Ordinance shall be subject to a fine of \$50.00. The fine shall be \$100.00 for each second and subsequent violation of the ordinance by the same owner.

C. The owner of the vehicle parked in contravention of this Ordinance shall be deemed to commit a separate violation for each 24 hour period during which time such vehicle remains unlawfully parked.

D. Upon passage of this Ordinance the Town of Redkey shall cause the attached described areas to be clearly marked to indicate that they are prohibited parking areas.

**SCHEDULE OF PROHIBITED PARKING AREAS
WITHIN THE TOWN OF REDKEY, INDIANA**

- I. The north side of Main Street from Meridian Street to 55 feet east of Meridian Street;
- II. The north side of Main Street between Oak Street and Ash Street;
- III. The east side of Meridian Street an area 20 feet from the intersection of Meridian Street and Bell Avenue and an area 20 feet east of Meridian Street on the north side of Bell Avenue;
- IV. On the east side of North Meridian Street an area of 20 feet north of the intersection of Delaware Street and Meridian Street and an area 20 feet east of the intersection of Delaware Street and Meridian Street on the north side of Delaware Street and an area 20 feet east of the intersection of Meridian Street and Delaware Street on the south side of Delaware Street;
- V. At the intersection of Main Street and Meridian Street the following areas: 50 feet to the east of the intersection of Meridian Street and Main Street on the north side of Main Street and 20 feet east of the intersection of Main Street and Meridian Street on the south side of east Main Street and 15 feet west of the intersection of Main Street on the North side of Main Street 20 feet west of the intersection of Main Street and Meridian Street on the south side of Main Street; 25 feet south of the intersection of Main Street and Meridian Street on the east side of Meridian Street and an area of 25 feet south of the intersection of Main Street and Meridian Street on the west side of Meridian Street.

TOWN OF REDKEY, INDIANA
ORDINANCE 2015-2

An Ordinance For the Regulation of Parking on Main Street between Walnut Street and Ash Street and between Oak Street and Ash Street

BE IT ORDAINED BY THE TOWN BOARD, OF THE TOWN OF REDKEY, JAY COUNTY, INDIANA THAT:

Section I: The purpose of this ordinance shall be to facilitate the flow of traffic on Main Street and the orderly parking of vehicles on Main Street.

Section II: For the purpose of this ordinance, the following definitions shall apply unless the context of the ordinance clearly indicates or requires a different meaning.

- a. **Vehicle:** For the purposes of this ordinance, a vehicle shall be any form of conveyance that is self-propelled including but not limited to automobiles, trucks of any size, motorcycles, motorized bicycles or all-terrain vehicles.
- b. **Owner:** For purposes of this ordinance, the owner of a vehicle shall be the last known record title holder of a vehicle according to the records of the Indiana BMV.

Section III: From the date of the adoption of this ordinance and thereafter, parking shall be prohibited on the South side of Main Street between Walnut Street and Ash Street.

Section IV: From the date of the adoption of this ordinance and thereafter, parking shall be prohibited on the North side of Main Street between Oak Street and Ash Street.

Section V: From and after the date of adoption of this ordinance, owners found in violation of this ordinance shall be subject to a fine of Ten Dollars (\$10.00). The fine shall be Twenty-five Dollars (\$25.00) for each second and subsequent violation of the ordinance by the same owner.

Section VI: The owner of a vehicle parked in contravention of this ordinance shall be deemed to commit a separate violation for each twenty-four (24) hour period during which time such vehicle remains unlawfully parked.

Section VII: Upon the passage of this ordinance, the Town of Redkey shall cause the above-described areas on Main Street to be clearly marked to indicate the prohibited parking areas.
