

**TOWN OF REDKEY
ORDINANCE NO. 2022-1**

An Ordinance amending Ordinance 2019-1 fixing the schedule of rates and charges to be collected by the Town of Redkey, Indiana from the owners of property served by the water works of said Town.

WHEREAS, the Town of Redkey established rates and charges to be collected for the use and service of the water works; and

WHEREAS, the Indiana General Assembly has repealed the Utility Receipts Tax effective July 1, 2022 and the Town's rates should be amended to reflect that tax's repeal.

BE IT ORDAINED BY TOWN COUNCIL OF THE TOWN OF REDKEY, INDIANA:

Section a(4) of Ordinance 2019-1 is hereby amended as follows:

(a)(4) Effective July 1, 2022, the water usage schedule on which the amount of said water rates and charges shall be determined shall be as follows:

<u>Quantity of Water Used</u> <u>per Month</u>	<u>Total User Charge</u>
First 2,000 gallons	\$16.24
Next 5,000 gallons	\$14.41
Next 10,000 gallons	\$8.36
Next 33,000 gallons	\$6.49
Next 66,000 gallons	\$5.55
Over 116,000 gallons	\$3.71

The minimum charge for any user, where the user is a metered water consumer, shall be based upon the meter sizes as follows:

<u>Meter Size</u>	<u>Per Month</u>
Up to .75 inch meter	\$32.48
1 inch meter	\$39.43
1 1/2 inch meter	\$57.95
2 inch meter	\$100.97
3 inch meter	\$154.58
4 inch meter	\$251.22
6 or larger inch meter	\$378.64
