WHEREAS, the petition was set for hearing on the 19th day of June, 2014, at 6:00 p.m. in the former Town Hall, 20 S. Ash Street, Redkey, Indiana after publication of notice in The Commercial Review and Dunkirk News & Sun as required by law, and

WHEREAS, all of the property owners adjacent to that part of Harison Street which was sought to be vacated and abandoned were given notice of the hearing by certified mail, and




