

Town of Roann Meeting Minutes

February 9, 2026

I. Call to Order

Neil Bever called to order the Regular Board Meeting for the **Town of Roann** at **7:00 p.m. on the 9th day of February, 2026 in Roann Town Hall.**

II. Roll Call

III. Approval of Minutes from last meeting

The Town Council read the minutes from the Regular Board Meeting on January 12, 2026, the minutes were approved as read.

Open issues

- a) Robert "M" Ferguson Jr. reported the park committee is planning a fundraiser for May 9, 2026.
- b) Robert "M" Ferguson Jr. stated the Annual Institute and Academy classes will be March 8-12, 2026 in Plainfield. Neil Bever made a motion to approve meals, mileage, hotel, and conference fee for Peggy Myers and Robert "M" Ferguson Jr. to attend. Jeremy Fisher seconded and the Town Council voted in favor 2-0.
- c) Kristina Lynn presented a Pull Track Agreement for the Council to review.
- d) Tony Janeway shared NIPSCO has advised there will be a cost to install gas line from the pole barn to sewer plant estimating around \$10,000.00. Tony Janeway has also checked on purchasing an LP 1000 gallon gas tank with copper lines and hook up which will cost approximately \$4,500.00 plus having to fill the tank.
- e) Tony Janeway advised Generac has some updates and the generator is back on hold.
- f) Neil Bever made a motion to approve Kristina Lynn to take legal action to get the property at 130 N. Church Street cleaned up. Jeremy Fisher seconded and the Town Council voted in favor 2-0.

New Business

- a) Neil Bever made a motion to move the next board meeting to March 2, 2026. Jeremy Fisher seconded and the Town Council voted in favor 2-0.
- b) Tony Janeway advised he is in need of a new chlorine scale with a quote of approximately \$1,000.00. Neil Bever made a motion to approve up to \$1,000.00 for a new chlorine scale. Jeremy Fisher seconded and the Town Council voted in favor 2-0.
- c) Steve Hicks advised he has a quote for new AED pads for \$233.99. Neil Bever made a motion to approve the AED pads. Jeremy Fisher seconded and the Town Council voted in favor 2-0.
