ORDINANCE NO. 3 -2018

AN ORDINANCE OF THE TOWN COUNCIL

OF THE TOWN OF ROANN, INDIANA

REGARDING THE REGULATION OF TRAFFIC

IN THE TOWN OF ROANN

WHEREAS, the Town of Roann, Indiana, by and through the Town Council, has the authority and responsibility, pursuant to I.C. 9-21-1-1, et seq., to regulate traffic and erect traffic control devices within the limits of the Town of Roann:

NOW, THEREFORE, BE IT ORDERED by the Town Council of the Town of Roann, Indiana, as follows:

SECTION I. That the movement and travel of motor vehicle traffic within the corporate limits of the Town of Roann, Wabash County, Indiana, shall be governed as follows:

- A. That vehicles traveling south on Church Street shall stop in observance of a stop sign before entering the intersection with Beamer Street;
- B. That vehicles traveling east and west on Allen Street shall stop in observance of stop signs before entering the intersection with Church Street;
- C. That vehicles traveling east on Allen Street shall stop in observance of a stop sign before entering the intersection with Arnold Street;
- D. That vehicles traveling north on Grant Street shall stop in observance of a stop sign before entering the intersection with Pike Street and that vehicles traveling south on the access road north of Grant Street shall stop in observance of a stop sign before entering the intersection with Pike Street;
- E. That vehicles traveling east on Walnut Street shall stop in observance of a stop sign before entering the intersection with Church Street and that vehicles traveling east on Walnut Street shall observe the "DO NOT ENTER" sign at the intersection with Church Street;
- F. That vehicles traveling west on Allen Street shall stop in observance of a stop sign before entering the intersection with West Street;
- G. That vehicles traveling south on Washington Street shall observe the yield sign before entering the intersection with Adams Street;
- H. That vehicles traveling west on Walnut Street shall observe the yield sign before entering the intersection with West Street;
- I. That vehicles traveling east and west on Adams Street shall observe the yield signs before entering the intersection with Benton Street;

- J. That vehicles traveling east and west on Walnut Street shall observe the yield signs before entering the intersection with Benton Street:
- K. That vehicles traveling east and west on Allen Street shall observe the yield signs before entering the intersection with Benton Street;
- L. That vehicles traveling east and west on Adams Street shall observe the yield signs before entering the intersection with West Street;
- M. That vehicles traveling east and west on Adams Street shall stop in observance of stop signs before entering the intersection with Arnold Street;
- N. That vehicles traveling east and west on Pike Street shall stop in observance of stop signs before entering the intersection with Church Street. That vehicles traveling north and south on Church Street shall stop in observance of stop signs before entering the intersection with Pike Street;
- O. That vehicles traveling east and west on Quincy Street shall stop in observance of stop signs before entering the intersection with Church Street;
- P. That vehicles traveling east and west on Allen Street shall stop in observance of stop signs before entering the intersection with Chippewa Street;
- Q. That vehicles traveling east and west on Walnut Street shall stop in observance of stop signs before entering the intersection with Chippewa Street;
- R. That vehicles traveling east and west on Adams Street shall stop in observance of stop signs before entering the intersection with Chippewa Street;
- S. That vehicles traveling east and west on Pike Street shall stop in observance of stop signs before entering the intersection with Chippewa Street;
- T. That vehicles traveling west on Quincy Street shall stop in observance of a stop sign before entering the intersection with Chippewa Street;
- U. That vehicles traveling west on Beamer Street shall stop in observance of a stop sign before entering the intersection with Chippewa Street;
- V. That vehicles traveling east and west on Pike Street shall stop in observance of stop signs before entering the intersection with Ohio Street;
- W. That vehicles traveling north and south on Arnold Street shall observe the yield signs before entering the intersection with Pike Street;
- X. That vehicles traveling east and west on Allen Street shall observe yield signs before entering the intersection with Washington Street;
- Y. That vehicles traveling east and west on Walnut Street shall observe yield signs before entering the intersection with Washington Street;

- Z. That vehicles traveling east and west on Quincy Street shall stop in observance of stop signs before entering the intersection with Arnold Street;
- AA. That vehicles traveling east on Quincy Street shall observe a yield sign before entering the intersection with Ohio Street and that vehicles traveling south on Ohio Street shall observe a yield sign before entering the intersection with Quincy Street;
- BB. That vehicles traveling east and west on Adams Street shall observe yield signs before entering the intersection with Church Street; and
- CC. That vehicles traveling north and south on Ohio Street shall observe yield signs before entering the intersection with Adams Street.

SECTION II. Any person violating the provisions of this Ordinance shall be subject legal process and penalties as set forth in I.C. 34-28-5-1 et.seq. A violation of this Ordinance shall be classified as a Class C Infraction.

SECTION III. This Ordinance shall be enforced by the Roann Town Marshall and/or any law enforcement officer authorized to enforce ordinances enacted by the Town of Roann.

SECTION IV. All ordinances of the Town of Roann in conflict with the provisions of this ordinance are hereby specifically repealed, including, but not limited to, General Ordinance #10, 1956 and General Ordinance No. 1, 1975.

SECTION V. This ordinance shall be in full force and effect from and after its adoption and approval by the Town Board of Roann, Wabash County, Indiana.
