4. Town asked that in the down time of the winter for Ralph and Cliff to clean up and organize the shop.

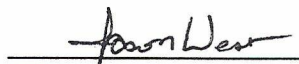
SEWER/ WATER REPORT/ BUSINESS- Cliff was absent due to illness but has been working on the water line. Board members will reach out to him this week for an update.

SHERIFF DEPARTMENT LIAISON REPORT- nothing to report

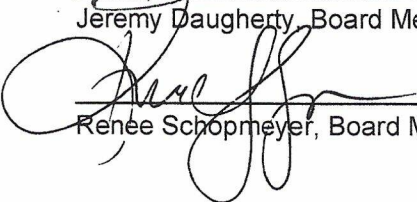
Jeremy motioned to adjourn at 5:34pm, Jason 2nd, motioned carried 3-0.

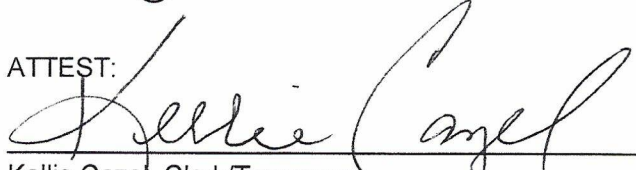
