9-8-1-1. Transportation of Oversize Vehicles.

9-8-1-1. Transportation of Oversize Vehicles:

(a) No person shall move any house, building or structure on, over or along any street or highway in the Town without first obtaining a permit to do so.

(b) Every applicant for a permit under this section shall sign a statement agreeing to save the Town harmless from any and all damage that may occur by such transportation for which the Town could be held liable.

(c) Every applicant for a permit under this section shall execute and deliver a good and sufficient bond with surety to the satisfaction of the President of the Board. The bond shall be filed with the Clerk-Treasurer and shall be conditioned to save the Town harmless from liability as required in subsection (b) and further conditioned that all highways, streets, trees and private property shall be left by the applicant in as good condition as they were before the transportation authorized by the permit.

(b) Any person who violates any provision of this section shall be deemed to have committed an ordinance violation and, upon conviction, shall be fined not less than Twenty-Five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00), in addition to court costs. If, however, any person receives a notice from the Police Department that he or she is charged with a violation of this section, that person may pay the sum of Fifteen Dollars (\$15.00) to the Clerk-Treasurer no later than seventy-two (72) hours following the receipt of notice and thereby preclude any further prosecution by the Town of the violation stated in the notice.

(a) No person shall move any house, building or structure on, over or along any street or highway in the Town without first obtaining a permit to do so.

(b) Every applicant for a permit under this section shall sign a statement agreeing to save the Town harmless from any and all damage that may occur by such transportation for which the Town could be held liable.

(c) Every applicant for a permit under this section shall execute and deliver a good and sufficient bond with surety to the satisfaction of the President of the Board. The bond shall be filed with the Clerk-Treasurer and shall be conditioned to save the Town harmless from liability as required in subsection (b) and further conditioned that all highways, streets, trees and private property shall be left by the applicant in as good condition as they were before the transportation authorized by the permit.

(d) No permit shall be issued until the applicant complies with subsection (b) and (c) and has paid a fee of Five Dollars (\$5.00) to the Town. The Clerk-Treasurer shall issue the permit which shall be countersigned by the President of the Board.

(e) Any person who violates any provision of this subsection shall be deemed guilty of an ordinance violation and, upon conviction, shall be fined not more than One Hundred Dollars (\$100.00), in addition to court costs.

9-8-6-35. Vehicle Noise:

(a) No person shall operate or cause to be operated any vehicle on or over any street, highway or public way in the Town so that it or its equipment or parts make, create, increase or maintain any grating, screeching, grinding, squeaking, loud report, shots, or other noise

which annoys, disturbs, injures or endangers the comfort, repose, health, peace and quiet of others.

(b) Any person who violates any provision of this section shall be deemed to have committed an ordinance violation and, upon conviction, shall be fined not less than Twenty-Five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00), in addition to court costs.
