STOP SIGN AT MARTIN AND JACKSON

WAGNER-MEINERT ANNUAL FURANCE CHECK

Brenda Conley presented a contract from Wagner-Meinert for the annual furnace and air condition check. It went up \$49.99 from last year so the amount is \$2115.00. They will come out this spring then again in the fall.

ORDINANCE 2022-01 VACATE

Nick Heffner asked if there were any utility easement on this right-of-way. Bill Eberhard stated no utility easement is present that he knows of. Nick Heffner asked the public if there were any comments and there were none. Nick Heffner asked for a motion to approve Ordinance #2022-01 on the first reading. Kirk Klein made the motion to approve. Cheryl Clifton seconds the motion. 3 ayes, 0 nays. Motion carried.


SEWER OPERATING: \$37,694.19


Next town council meeting is April 11, 2022 at 6:30pm at the Rome City Town Hall, 402 Kelly St., Rome City, IN
