Cheryl Clifton asked for a motion to waive the reading of the minutes from the last meeting. Kirk Klein seconded the motion. 3 ayes, 0 nays. Motion carried.

**Promise Land and Kelly's Salvage Subdivision Right of Way Dedication:** Leigh presented the replat of Promise Land Estates and Kelly's Salvage Subdivisions. She informed the council both plats show dedication of ROW to the town; the ROW for the Replat of Promised Land Estates is along the west side of Eastgate Drive and the ROW for Kelly's Salvage is located on the south side of Kelly Street Extended. Cheryl Clifton made a motion to approve the dedications of right of ways. Kirk Klein seconded the motion. 3 ayes, 0 nays. Motion carried. See attached plats for ROWs.

**Humane Society Invoice for 2025:** Heidi presented the Humane Society invoice for 2025 services. Pricing is the same as 2024 at \$3,000.00. Cheryl Clifton made a motion to approve payment of the invoice. Kirk Klein seconded the motion. 3 ayes, 0 nays. Motion carried.

**Contract for Gary Cox:** Heidi presented the Council with the contract for Gary Cox's IT services for 2025 at the same rate as 2024 at \$4,000.00. Kirk asked for a motion to approve the contract for Gary Cox. Cheryl Clifton seconded the motion. 3 ayes, 0 nays. Motion carried.

Leigh presented to the Council the new yearly trade-in program with BobCat for the skid steer at \$2,000.00 per year. Cheryl Clifton asked for a motion to approve using the trade-in program. Kirk Klein seconded the motion. 3 ayes, 0 nays. Motion carried.

Leigh informed the Council that Brightspeed fiberoptic is going to be installed in Rome City with 85% of the lines running above ground and 15% underground.


Leigh will contact Strawser Construction regarding the security window. We will need to obtain additional quotes from other contractors.

Reports were given by Manager Pranger, the year- end for Building Permits, Plan Commission and BZA; Scott Neukom submitted the year end utility report and read the monthly Utility Department report; Marshal Hoffman gave the Marshal's Department monthly report and submitted the year end report.

Cheryl Clifton asked for a motion to approve payment of the town and sewer bills. Kirk Klein seconded the motion. 3 ayes, 0 nays. Motion carried.


