**AN ORDINANCE OF THE TOWN OF TRAIL CREEK, LAPORTE COUNTY, INDIANA,
AUTHORIZING ADDITIONAL APPROPRIATIONS**

IN THE LIT – PUBLIC SAFETY FUND FOR THE 2024 BUDGET

WHEREAS, it has been determined that it is now necessary to appropriate more money than was originally appropriated in the annual budget in the LIT - Public Safety Fund of the Town; and

WHEREAS, the Council is aware that the Fund currently holds sufficient cash balance and are expected to receive additional miscellaneous revenues throughout the year to support the requested additional appropriation, and
