The Trail Creek Town Council met in regular session on Tuesday, June 17, 2025, at 7:00 p.m., at the Trail Creek Town Hall, 211 Rainbow Trail, Trail Creek, Indiana. Mrs. Heath, Council President led the pledge of allegiance.

Amendment: Mrs. Heath would like to add a letter from Tim Werner to the Agenda. A motion was made by Mr. Schacht to amend the agenda to add Mr. Werner to new business. The motion was seconded by Mr. Pizarek. Motion carried.

Minutes: A motion was made by Mr. Schacht to approve the meeting minutes; the motion was seconded by Mrs. Saenz. Motion unanimously carried.

Approval of Fund Report: Clerk Treasurer, Crystal Frever provided copies of the Fund Report for May 2025. A motion was made by Mrs. Saenz to approve the fund report; the motion was seconded by Mr. Pizarek. Motion was unanimously carried.

Bank Reconciliation: Clerk Treasurer, Crystal Frever provided copies of the May Bank Reconciliation.

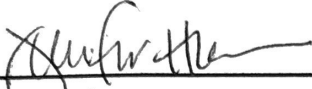
Public Comment: No Comment

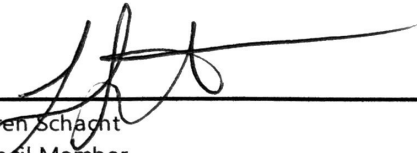

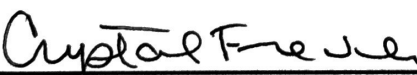
