

RESOLUTION NO. 1 - 2026

A Resolution to Void Stale Dated Checks Outstanding and Unpaid for a Period of Two or More Years and All Matters Related Thereto.

WHEREAS, the Town Council ("Council") of the Town of Trail Creek, LaPorte County, Indiana ("Town"), has been advised by the Financial Clerk that as demonstrated through a Stale Dated Check Report (Attached hereto as Exhibit "A") an amount of \$448.77 in stale dated checks have remained outstanding and unpaid for a period of two or more years; and

WHEREAS, the Council has reviewed the applicable state law under I.C. 5-11-10.5 et seq. regarding the voiding of stale dated checks within a town; and

WHEREAS, the Council has determined that the state law permits stale dated checks, which have remained outstanding and unpaid for a period of two or more years to be voided by the Town; and

WHEREAS, the Council having reviewed and considered all recommendations, and being duly advised, now concurs that it is advisable, necessary, appropriate, and in the best interests of the residents of the Town to void the stale dated checks, which have remained outstanding and unpaid for a period of two or more years and attached hereto as Exhibit "A", in accordance with applicable law, as amended from time to time.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF TRAIL CREEK AS FOLLOWS:

SECTION ONE: The Stale Dated Check Report, attached hereto as Exhibit "A", and identified as the Town of Trail Creek Stale Dated Check Report 2026, which contains a detailed breakdown of stale dated checks and have remained outstanding and unpaid for a period of two or more years, is hereby accepted by the Council.

SECTION TWO: That the Clerk-Treasurer of the Town, pursuant to the applicable procedures of the State Board of Accounts, is hereby authorized to void stale dated checks, which have remained outstanding and unpaid for a period of two or more years in the amount of Four Hundred Forty-Eight and 77/100 Dollars (\$448.77), as "stale dated checks" as same is deemed void. Said value shall be recorded as a receipt to the proper Fund(s).

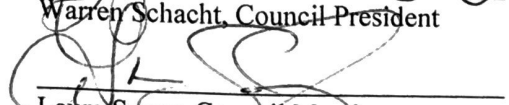

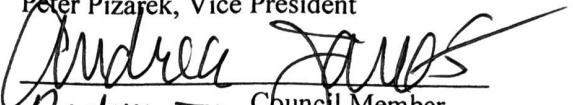

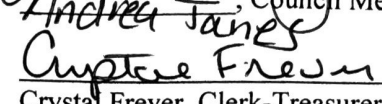
