



Utilities

The Utility Superintendent submitted the first set of water samples for testing today, following the boil order issued yesterday. Based on initial assessments, we anticipate the test results will meet safety standards. A second required test is scheduled for tomorrow. If both results are clear, we expect to lift the boil order by Thursday, pending final confirmation.

Administrative

- A new residential construction permit has been issued for a property on South Street.



- The town has received a request to consider allowing geocaching on municipal properties. I have been tasked with preparing a list of potential advantages and disadvantages for further discussion (See Attached Report)
- In coordination with Eastbrook Community Schools, the town will be removing the old buildings located across the street from the elementary school. Additionally, we will dismantle fencing and other infrastructure owned by the school on that property as part of the site improvement.
