

RESOLUTION NO. 2023-10

A RESOLUTION TO FILL TOWN COUNCIL MEMBERSHIP VACANCY

WHEREAS, the Town of Westport, Indiana, (“Town”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected legislative body (“Town Council”);

WHEREAS, Indiana Code § 36-5-2-4.2 provides that the legislative body may adopt a resolution to submit a public question on the number of legislative body members to the voters of the town;

WHEREAS, on June 12, 2023, the Town Council adopted Resolution No. 2023-9 to submit to the voters of the Town a public question concerning increasing the number of members on the Town Council from three (3) to five (5) members;

WHEREAS, on November 7, 2023, the general election results confirmed that a majority of voters answered affirmatively to the public question concerning increasing the number of members on the Town Council from three (3) to five (5) members;

WHEREAS, Indiana Code § 36-5-2-4.2(e) states, in pertinent part, that “[i]f a majority of votes cast on the question . . . are in the affirmative, the legislative body shall adopt an ordinance at its next regular meeting following the election altering the number of legislative body members to the number specified in the public question. . . . An ordinance adopted under this subsection becomes effective January 1 following its adoption.”

WHEREAS, pursuant to Indiana Code § 36-5-2-4.2(e) the Town Council shall adopt an ordinance increasing the number of members on the Town Council from three (3) to five (5) members at its next regular meeting on November 13, 2023;

WHEREAS, on November 13, 2023, the Town Council adopted Ordinance 2023-5, pursuant to Indiana Code § 36-5-2-4.2(e), increasing the number of members on the Town Council from three (3) to five (5) members effective January 1, 2024;

WHEREAS, Indiana Code § 36-5-2-4.2(f), states, in pertinent part, that “[t]he legislative body may fill the vacancy before the ordinance described in subsection (e) takes effect.”

WHEREAS, the Town Council desires to fill the vacancies before Ordinance 2023-5 takes effect on January 1, 2024, by appointing members to the two (2) council positions.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Westport, Indiana, in accordance with the provisions of Indiana Code § 36-5-2-4.2(f), as follows:

The following members are hereby appointed to the Westport Town Council:

1. Dennis K. Honeycutt ; and
2. Jennifer Hoyb
