AN ORDINANCE ESTABLISHING A DOWNTOWN SIDEWALKS AND LIGHTING FUND

Ordinance No. 13 of 2019

WHEREAS, the Town Council of the Town of Winamac, Indiana (the "Town Council"), is responsible for the performance of various functions for the Town of Winamac (the "Town"); and

WHEREAS, the Town has been awarded a grant for One Million Thirty-Nine Thousand Eight Hundred Dollars (\$1,039,800.00), from the Indiana Department of Revenue, for certain renovations to the sidewalks and lighting in the Town's Downtown areas; and

WHEREAS, the Town will be required to match a portion of this grant money with matching funds from the Town's Electric Department; and

WHEREAS, the Town is desirous of creating a separate fund for the receipt of all distributions by the Indiana Department of Revenue for renovations to the sidewalks and lighting in the Town's Downtown areas, as well as to receive transferred funds from the Town of Winamac's Electric Department.

NOW, THEREFORE, **BE IT RESOLVED**, by the Town Council of the Town of Winamac, Indiana, that the following Ordinance Establishing a Downtown Sidewalks and Lighting Fund, is hereby adopted as follows:

Section I.

Establishment

- 1. **Downtown Sidewalks and Lighting Fund**. Be it now resolved, that the Town Clerk-Treasurer is hereby authorized to create a new Fund for the receipt of the aforementioned funds from the Indiana Department of Revenue, as well as to transfer already-existing funds from the Town's Electric Department, as matching moneys. Such fund shall be called the Downtown Sidewalks and Lighting Fund.
- 2. **Non-Reverting**. The Downtown Sidewalks and Lighting Fund shall be a perpetual fund, and expenditures can be made from the Fund only for those purposes as enumerated in this Ordinance.
- 3. **Authorized Use of Funds**. Moneys received, or transferred, shall be used for renovations to the downtown areas of the Town of Winamac, and for those purposes further identified in the grant administration documents set forth by the State of Indiana.

Section II.

Effective Date

1. **Effective Date.** The Downtown Sidewalks and Lighting Fund shall be established as of the date of passage of this Ordinance, and shall be of perpetual existence, or until this Ordinance is duly repealed by the Town Council of the Town of Winamac.
