AN ORDINANCE REGULATING THE DEPOSIT AND USE OF GUN PERMIT APPLICATION FEES

Ordinance No. 4 of 2019

WHEREAS, the Town Council of the Town of Winamac, Indiana (the "Town Council"), is responsible for the performance of various functions for the Town of Winamac (the "Town"); and

WHEREAS, the Town, by and through its Town Police Department, regularly receives Gun Permit Applications, and collects the associated fees for that service; and

WHEREAS, the Town, pursuant to state law, is entitled to keep a portion of those fees for its usage, provided such usage complies with Ind. Code § 5-2-8; and

WHEREAS, the Town Council is further required to establish controls for the deposit and use of such fees.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Winamac, Indiana, that this Ordinance Regulating the Deposit and use of Gun Permit Application Fees, is hereby adopted as follows:

SECTION I.

Collection and Deposit

- 1. **Authorized Fee.** The Town of Winamac Police Department (the "**Department**") is hereby instructed and authorized to collect the sum of Ten Dollars (\$10.00) or such other amount as hereafter permitted by Indiana Law, for the processing of each Gun Permit Application submitted to the Department.
- 2. All funds collected by the Department with each Gun Permit Application, shall be delivered by the Department to the Town Clerk-Treasurer's Office, who shall deposit all such funds turned over by the Department from Gun Permit Applications into the Law Enforcement Continuing Education Fund.
 - 3. The collection of all such fees shall be subject to the Town's internal controls policy.

SECTION II.

Authorized Use of Funds

- 1. The Town shall utilize such Gun Permit Application Fees so collected at the direction of the Town Council, and only for the following purposes, pursuant to Ind. Code § 5-2-8-6:
 - (a) Continuing Education and Training of Law Enforcement Officers employed by the Department; and

(b) Equipment and supplies for law enforcement purposes.

SECTION III.

Effective Date

This Ordinance shall become effective immediately upon its passage, in a meeting that has been properly advertised, and open to the general public. Upon passage of this Ordinance, Ordinance Number 8 of 1997, is hereby repealed, in its entirety.
