RESOLUTION 26-4B

**APPROVING A 2026 BONUS FOR THE EMPLOYEES OF
CENTER TOWNSHIP, MARION COUNTY, INDIANA**

WHEREAS, the legislative body of Center Township, Marion County, Indiana ("Center Township") is a five (5) member board established by the laws found in Indiana Code § 36-6-6, *et. al.* ("Township Board");

WHEREAS, the Township Board, as the governing body, is responsible for overseeing all fiscal matters obligating Center Township;

WHEREAS, Indiana Code § 36-6-6-10 *et. seq.* states except as provided in subsection (i), the township legislative body may not alter the salaries of elected or appointed officers during the fiscal year for which they are fixed, but it may add or eliminate any other position and change the salary of any other employee if the necessary funds and appropriations are available.

WHEREAS, the Trustee, Judge and Township Board are desirous to provide a one time bonus to the employees of the Township for their outstanding service to the residents of the Township and sufficient funding is projected to be available.

NOW, THEREFORE, BE IT RESOLVED by the Center Township Board having the jurisdiction over the compensation of the Township's employees, do hereby approve this resolution, and amends the previously approved salary resolution to provides a one-time bonus of up to one thousand dollars (\$1,000.00) for each employee of the Township.

NOW, BE IT FURTHER RESOLVED by the Center Township Board that the Township Trustee and Small Claims Court Judge are hereby authorized to determine the per employee bonus amount up to a maximum of one thousand dollars (\$1,000.00) per employee.
